SK Finance Drives Financial Inclusion with 70% Vehicle Loans to Rural and Semi-Urban India's Unbanked

Ahmedabad, Founded in 1994 by Rajendra Kumar Setia, the Company addresses the lack of institutional credit for small transporters and traders across 12 states through 648 branches, over 12,000 employees and a referral network of over 10,700 connectors.

The used vehicle financing market is growing, driven by rising consumption, value-conscious consumers and the increase in the availability of formal credit in rural and semi-urban India. This structurally is led by an increase in the economic activity in rural and semi-urban India across product segments

catering to the basic consumption requirements of the local ecosystem.

The company has filed its DRHP which details a total offer size of ₹2,200 crore IPO, comprising a ₹500 crore primary issue and ₹1,700 crore offer for sale. The capital will be used to bolster tier-1 capital and support future growth.

Business Brief

Sensex, Nifty open lower as midcap and smallcap hold markets

Mumbai, July 18 (IANS) The Indian equity indices opened lower on Friday as heavyweights like Axis Bank and Bharti Airtel were among the top losers in the BSE benchmark.

At 9.25 am, Sensex was down 171 points or 0.21 per cent at 82,087 and Nifty was down 35 points or 0.14 per cent at 25,075. In the Sensex pack, M&Tata Steel, Power Grid, L&T, UltraTech Cement, Infosys, Tata Motors, BEL, NTPC, TCS, Trent and Maruti Suzuki were top gainers. Axis Bank, Bharti Airtel, Kotak Mahindra Bank, Tech Mahindra, HDFC Bank, Eternal (Zomato), HUL, Sun Pharma, Bajaj Finance, ICICI Bank, Titan and Bajaj Finserv were top losers. On the sectoral front, auto, IT, PSU bank, metal, realty, media, energy, infra, PSE and commodities were major gainers, while financial services, FMCG and private bank were in the red. "In July, so far, India has been underperforming most markets, with a dip of 1.6 per cent in Nifty. A significant contributor to the decline is the selling by FII. There is a clear pattern in FII activity this year so far," said Dr VK Vijaykumar, Chief Investment Strategist, Geojit Investments Limited.

India remains a compelling investment destination globally: Report

New Delhi, July 18 (IANS) India remains a compelling investment destination worldwide, owing to stability, structural reforms and a resilient consumer base, leading global investment firm KKR has stressed. KKR, in its '2025 Mid-Year Global Macro Outlook,' said India's growth prospects and favourable market conditions make it an attractive opportunity for investors. "From a macro perspective, India's relative insulation from global trade friction remains intact, supported by its predominantly domestic, consumer-driven economy," the report stated. "We continue to see India as one of the most compelling strategic allocations within emerging markets today," it added. The report, published by KKR's Global Macro & Asset Allocation team, emphasised India's unique position as a scalable opportunity amid a shift from benign globalisation to great power competition.
